Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (h)

Description and Location of Proposed Activity:

The proposed project involves buffer encroachments necessary to construct a commercial travel stop and associated infrastructure west of Interstate 75 and north of Rumble Road in Monroe County. Additionally, an onsite stormwater management system (including detention basins and proprietary systems) will be included. The project will require 27.67 acres of land disturbance including permanent impacts (pipe/fill) to 228 total linear feet (21,394 total square feet) of buffer along two unnamed dendritic tributaries to Deer Creek in the Upper Ocmulgee Watershed (03070103).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
